MT. PLEASANT TOWNSHIP ORDINANCE NO. 11-1973

IT IS HEREBY ENACTED AND ORDAINED by the Board of Supervisors of Mt. Pleasant Township, Columbia County, Pennsylvania:

ARTICLE I: Title

- 1.01 <u>Long Title:</u> An ordinance requiring all persons, partnerships, businesses and corporation to obtain a building permit for the construction, reconstruction, enlargement, alteration, or relocation of any building or structure: providing for the issuance of such building permits; and providing for penalties for any persons who fail or refuse to comply with the requirements or provisions of this ordinance.
 - 1.02 <u>Short Title:</u> This ordinance shall be known as the "Building Permit Ordinance".

ARTICLE II: Statement of Intent

- 2.01 It shall be unlawful for any person, partnership, business or corporation to undertake or cause to be undertaken, the construction, reconstruction, enlargement, alteration, or relocation of any building or structure unless an approved building permit has been obtained from the Municipal Building Permit Officer.
- 2.02 A building permit shall not be required for repairs to existing buildings or structures, provided that no structural changes or modifications are involved.

ARTICLE III: Definitions

- 3.01 For the purposes of this ordinance, the following definitions shall apply:
 - a) Building a combination of materials to form a permanent structure having walls and a roof. Included shall be all mobile home and trailers to be used for human habitation.
 - b) Person any person, persons, partnership, business or corporation.
 - c) Structure a combination of materials to form anything permanently affixed to or in the ground or to any other building or structure permanently affixed to or in the ground. Included shall be such things as driveways, carports, porches, swimming pools, etc.

ARTICLE IV: APPLICATION PROCEDURE

- 4.01 Application for such a building permit shall be made in writing to the Building Permit Officer on forms supplied by the municipality. Such application shall contain at least the following:
 - a) Name and address of applicant.
 - b) Name and address of owner of land on which proposed construction is to occur.
 - c) Name and address of contractor.
 - d) Site locations.
 - e) Brief description of proposed work and estimated cost.
 - f) A plan of the site showing the exact size and location of the proposed construction as well as any existing buildings or structures.

ARTICLE V: ISSUANCE OF PERMIT

5.01 The Building Permit Officer shall issue a building permit only after it has been determined that the proposed construction will be in conformance with all applicable requirements and regulations.

ARTICLE VI: PERMIT CHANGES

6.01 After the issuance of a building permit by the Building Permit Officer, no changes of any kind shall be made to the application, permit, or any of the plans, specifications or other documents submitted with the application without the written consent or approval of the Building Permit Officer.

ARTICLE VII: PLACARDS

7.01 In addition to the building permit, the Building Permit Officer shall issue a placard which shall be displayed on the premises during the time construction is in progress. This placard shall show the number of the building permit, the date of its issuance and be signed by the Building Permit Officer.

ARTICLE VIII: START OF CONSTRUCTION

8.01 Work on the proposed construction shall begin within six (6) months after the date of issuance of the building permit or the permit shall expire unless a time extension is granted, in writing, by the Building Permit Officer. Construction shall be considered to have started with the first placement of permanent construction on the site, such as pouring of slabs or footing or any work beyond the stage of excavation. For a structure without a basement or poured footings, the start of construction includes the first permanent framing or assembly of the structure or any part thereof on its pilings or foundation, or the affixing of any prefabricated structure or mobile home to its permanent site. Permanent construction does not include land preparation, land clearing, grading, filling, excavation for basement, footings, piers, or foundations; erection of temporary forms; the installation of piling under proposed subsurface footings; or the installation of sewer, gas, and water pipes, or electric or other service lines from the street.

ARTICLE IX: INSPECTION AND REVOCATION

9.01 During the construction period, the Building Permit Officer or other authorized official may inspect the premises to determine that the work is progressing in compliance with the information provided on the permit application and with all applicable municipal laws and ordinances. In the event the Building Permit Officer discovers that the work does not comply with the permit application or any applicable laws or ordinances, or that there has been a false statement or misrepresentation by any applicant, the Building Permit Officer shall revoke the building permit and report such fact to the Board of Supervisors of Mt. Pleasant Township for whatever action it considers necessary.

ARTICLE X: FEES

10.01 Applications for a building permit shall be accompanied by a fee, payable to the municipality, based upon the estimated cost of the proposed construction as determined by the Building Permit Officer a the following rates:

ARTICLE XI: APPEALS

11.01 Any person aggrieved by the Building Permit Officer's estimate of the cost of the proposed construction may appeal to the Board of Supervisor of Mt. Pleasant Township. Such appeal must be filed, in writing, within thirty (30) days after the determination by the Building Permit Officer. Upon receipt of such appeal, the Board of Supervisors of Mt. Pleasant Township shall set a time and place not less than ten (10) nor more than thirty (30) days for the purpose of hearing the appeal. Notice of the time and place of the hearing of the appeal shall be given to all parties at which time they may appear and be heard. The determination of the estimated cost by the Board of Supervisors of Mt. Pleasant Township shall be final in all cases.

ARTICLE XII: PENALTIES

12.01 Any person who fails to comply with any or all of the requirements or provisions of this ordinance or who fails or refuses to comply with any notice, order or direction of the Building Permit Officer or any authorized employee of the municipality shall be guilt of an offense and, upon conviction, shall pay a fine to Mt. Pleasant Township of not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) plus costs of prosecution. In

default of such payment, such person shall be imprisoned in county prison for a period not to exceed ten (10) days. Each day during which any violation of this ordinance continues shall constitute a separate offense. In addition to the above penalties all other actions are hereby reserved including an action of equity for the proper enforcement of this ordinance. The imposition of a fine or penalty for any violation of, or non-compliance with, this ordinance shall not excuse the violation or non-compliance or permit it to continue; and all such persons shall be required to correct or remedy such violations and non-compliances within a reasonable time. Any structure or building constructed, re-constructed, enlarged altered, or relocated, in non-compliance with this ordinance may be declared by the Board of Supervisors of Mt. Pleasant Township to be a public nuisance and abatable as such.

ARTICLE XIII: SEVERABILITY CLAUSE:

13.01 If any section, paragraph, sentence or phrase of this ordinance should be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this ordinance which shall remain in full force and effect. For this purpose the provisions of this ordinance are hereby declared to be severable.

ARTICLE XIIII: EFFECTIVE DATE

14.01 This ordinance shall become effective on the 8th day of December 1973, and shall remain in force until modified, amended, or rescinded by the Board of Supervisors of Mt. Pleasant Township, Columbia County, Pennsylvania.
