

ORDINANCE OF THE TOWNSHIP OF MOUNT PLEASANT,
COUNTY OF COLUMBIA AND STATE OF PENNSYLVANIA
ORDINANCE NUMBER 1988 – 28

AN ORDINANCE AMENDING THE PER CAPITA TAX ORDINANCE OF THE TOWNSHIP OF MOUNT PLEASANT, COUNTY OF COLUMBIA, COMMONWEALTH OF PENNSYLVANIA.

THE FOLLOWING IS HEREBY ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF MOUNT PLEASANT TOWNSHIP, COUNTY OF COLUMBIA AND COMMONWEALTH OF PENNSYLVANIA, AND THE SAME IS HEREBY ENACTED BY AUTHORITY OF THE SAME PURSUANT TO THE LOCAL TAX ENABLING ACT OF THE COMMONWEALTH OF PENNSYLVANIA.

Section 1. This amendment to the Mount Pleasant Township Per Capita Tax Ordinance together with the original Ordinance shall be known as and may be cited as the Mount Pleasant Township Per Capita Tax Ordinance.

Section 2. Pursuant to PL 1257 Section 1, December 31, 1965, 53PS Section 6901, Section 6902, and Section 6908, known as “The Local Tax Enabling Act”, the Township of Mount Pleasant, County of Columbia and Commonwealth of Pennsylvania hereby amends its Per Capita Tax Ordinance and levies and assesses a tax upon adult individuals residing in the Township of Mount Pleasant, Columbia County, Pennsylvania.

Section 3. The rate of said Per Capita Tax is hereby amended to provide for an additional Three (\$3.00) Dollars for each calendar year on each adult individual who resides within the Township of Mount Pleasant, so that the rate of said Per Capita Tax pursuant to the original Ordinance and this Amendment thereto shall be limited to a total of Five (\$5.00) Dollars for each calendar year on each adult individual who resides within the Township of Mount Pleasant.

Section 4. Payment of said Per Capita Tax shall be made to the Township of Mount Pleasant pursuant to such procedures and regulations as the Board of Supervisors shall establish by resolution.

Section 5. The invalidity of any Section or Provision of this Ordinance shall not invalidate the entire Ordinance.

Section 6. This Ordinance shall become effective at the earliest date permitted by law after enactment.
