- -Resident Robbins questioned the condition of the bridge to the cell tower locations. Larson inspected. AT&T will gunnite/shotcrete both sides. Bridge will then handle 80,000 lbs easily.
- -Supervisors will ask Resident Randy Oman for permission to remove front area from abandoned building at the intersection of Peacock Corners & Whites Church Roads. Motorists do not have a clear view of oncoming traffic in that area.
